**Electrolysis Treatments** are a form of electrical epilation where a wire filament (needle) is inserted into the hair follicle and a minimal amount of current is delivered to the root of the hair to destroy it through a variety of modalities. All modalities will treat only the offending hair follicle, making this a non-invasive and more direct route to target unwanted hair.

**Galvanic Electrolysis** - Galvanic electrolysis is the oldest type of this hair removal. The direct current used extremely effective but very slow. It creates a chemical change in the follicle to to destroy the route.

**Thermolysis Electrolysis** - Thermolysis used shortwave radio frequency or AC current. Thermolysis causes the water molecule by your hair to rapidly vibrate, which produces heat. When enough heat is created, thermolysis damages the cell that causes hair growth.

**Blend Electrolysis** - True to its name, blend combines both galvanic and thermolysis methods in one treatment. If one type of electrolysis doesn't kill your unwanted hair the other well.

#### What To Expect

Our hair is constantly changing from a number of factors that make us who we are, it's in our DNA. It is the diversity that makes proper hair removal through electrolysis a process. As our body reacts to different situations such as hormones, medications, weight and even our genes, our hair growth patterns change and may activate dormant hair follicles. The complex nature of hair growth controls the number of sessions required to each reach your personal preference of hair removal.

Generally, Electrolysis is typically noticeable within three months and can take up to 12+ months for complete and permanent results. We offer sessions from five minutes to an hour, recommend weekly schedule so treating the follicle right when it emerges and at the optimal time for optimal reaction. Our goal is to see this process through to ensure complete satisfaction. Each individual has a different tolerance level, and that is taken into account. Modern electrolysis methods can be described as causing a tingling or warming sensation, Topical desensitizing cream can be applied to help ease the sensation. After your treatment, it is common to experience redness or swelling, both of which are usually short-lived. These are both natural reactions from the stimulus applied to the follicle and can be eased with the use of an ice pack and witch hazel. In order to prevent any additional reactions, it is critical that you inform us of any medical conditions, medication, supplements, lotions and oils.

I understand that the frequency and longevity of treatments is determined solely by my body's natural hair growth and therefore not predetermined.

### Before Your Treatment

- If you are treating sun exposed areas, apply sunblock of at least SPF 50 each morning for one month before treatment.
- Refrain from bleaching, tweezing, threading of hairs in desired treatment area for six weeks. It is fine to cut, shave or trim the area as desired.
- If you have a history of herpes or cold sores, you may need antiviral medication. This medication should start One day before and continue for one week after treatment or as directed.
- I am not taking any photosensitive medications, using peels or any other products that make my skin sensitive.
- The area for treatment needs to have a short stubble or longer
- Arrive with the treatment area clean and free of make-up, lotions or oils if possible.
- Any questions or concerns please reach out, we are here to help.

### Post Care

- Treat the area gently by keeping the skin moist with healing ointment for a few days. Three times a day for three days
- Cleanse the area with healing agents and avoid using soap or abrasive material when you are 24 hours post treatment.
- Do not pack, rub or scratch the area. Do not use any irritating substances on the treated area until the skin returns to normal.
- If the treated area will be exposed to sun, apply SPF 50 or greater after the skin returns to normal
- If your face was treated, you may resume using clean make up when the skin looks and feels back to normal. Test in a small area to start. If there are any issues, please call us and or your doctor.
- Exfoliation is recommended to prevent and grounds and enhance the health of your skin.
- Healing kits are available for home care
